The Club reports a deficit of £1,122 in the year, however the club remains in a sound financial position

This was a year of significant change for the Club and one which we entered uncertain as to the financial impact of moving to our new home of the AAA.

Fees were increased at last year's AGM to accommodate the increase in let costs, which were largely as predicted and generously supported by our landlord, East Ayrshire Council and East Ayrshire Sports Council.

The attraction of a fantastic new facility and the Olympic legacy however saw an explosion in membership, particularly the junior section, where a waiting list had to be introduced.

Senior membership numbers were marginally higher at 108 (93)

Fees were increased last year in anticipation of the increased let costs at AAA. With membership numbers much higher than anticipated this resulted in a growth in income above expectations.

These monies allowed us to purchase additional sports equipment, shelters for use at track and XC events and refresh the club website. In the last month, since the year end, additional sports equipment has also been purchased.

We were also able to have club clothing available for sale to members for the first time in a number of years.

We were successful in an application for a Big Lottery Funds Grant and these monies will be used to purchase clothing for volunteers and coaches in recognition of their contribution to the club.

The Hot Cross Run was run for the 2nd year but again attracted a relatively low turnout. With a wide variety of races nearby attracting larger numbers we have decided to cancel this event for the forseable future.

The Club once again hosted the Ruby Young Race which raised £980 for the Ayrshire Hospice.

A number of events were held to celebrate our 125 year anniversary. These were excellently organised by the 125 committee, were well attended by members and budgeted well. Financial support for the 125 events was generously provided by McSherry Halliday, Barnetts, Hamilton Tarmac, Mackies, McKenzie Bryson and Marshall, Netherlandscapes, Burn Stewart and many more.

The Club are grateful for the financial assistance of sponsors and supporters of the Club this year - East Ayrshire Sports Council, Clydesdale Bank, the Big Lottery Fund and Levelone Creative (website developers).
